# Rebecca J. Wright, Treasurer

# Budget Report June, July, 2025

Mr. Cullip stated the end of June the budget was over 106% on General Fund Revenues and General Fund Expenditures were underspent \$5,000. Enterprise Revenue Fund was good and Enterprise Fund Expenditures were at 95%. Everything looks good for the start of the new budget year.

# Grant Updates/Brown Field Grant

Mr. Cullip stated the RFP went out and there has been some interest. Due date is August 25, 2025. The committee met and everything is on track. There should be an engineer hired in the next couple of months.

# DEQ Grant update

Mr. Cullip stated this was the assessment grant. The grant is showing \$9,000 not spent. Since then CHS has completed and sent some other testing in, so this should cover the \$9,000 in question.

# Squad 10 update on agreement

Mr. Cullip stated Chris Vaughn, Street Department Supervisor called Jesse Miller, Assistant Resident Engineer with VDOT inquiring on an update. Mr. Miller stated something was not right in the county's memorandum and would be getting in touch with them to see what needs to be done.

# Dublin Treat Trail-October 31, 2025 at Dublin Police Department

Mr. Cullip stated he has been asked to bring back the Treat-Trail to the town and business. The town has been participating in the Jack-O-Lantern Spectacular event sponsored by the chamber. Sherri Bralley, Administrative Assistant in the Police Department has stated businesses have been in contact with her expressing interest in bring back the treat trail. Mrs. Bralley will get in touch with all the businesses and put the map together to be handed out. Council, agreed it would be good to bring the treat trail back into the town and for local businesses.

# Council date changes 11/20/2025 to 11/19/2025 Due to Chamber event on 11/20/2025

Mr. Cullip stated he would like to seek approval to change the November 20<sup>th</sup> council meeting to Wednesday, November 19<sup>th</sup> due to the Chambers annual meeting and awards banquet. Council agreed to move the November council meeting to Wednesday, November 19, 2025. Mr. Cullip encouraged council members to attend.

# Water improvement grant/Pulaski County

Mr. Cullip stated Town of Pulaski, Pulaski County and Town of Dublin have been looking at putting in for this grant. The towns and county decided to go in together and apply for the grant instead of splitting it up. Pulaski County was awarded the one-million-dollar water improvement grant. Mr. Cullip stated he has been working with Pulaski County Administrator Jonathan Sweet and Town of Pulaski Town Manager Todd Day to figure out how it's going to be split to work for everyone.

There were no public comments. Edith Hampton suggested looking at scheduling a work session. Mr. Cullip stated he would look at several dates and get back with council on scheduling a work session and Personnel Committee work session.
