

**Town of Dublin
Council Minutes
November 19, 2025**

The Town of Dublin held its monthly meeting on Wednesday, November 19, 2025 at 7:00 pm, in Council Chambers. Present: Mayor Debbie Lyons. Council members present: Juliana Cox, Debbie Hager, Edith Hampton, Doug Poe, Jared Smith and Wayne Seagle. Others present: Town Manager and Clerk of Council Darrin Cullip, Chief of Police David King, Jr. Treasurer Rebecca Wright and Administrative Assistant Deanna Marshall.

Call to Order

Mayor Lyons welcomed everyone and called the meeting to order.

Pledge of Allegiance

Mayor Lyons asked everyone to stand for the pledge of allegiance. Mayor Lyons stated the town had recently lost an important resident, Doug Irvin Sr. Doug served on council for 20 years, serving a portion of those as vice mayor, representing the town on several committees and close to 50 years with the Dublin Fire Department. A moment of silence was taken in his remembrance.

Open Public Hearing “Proposed Prohibition of through large truck traffic on Giles Avenue (Town Road) in the Town of Dublin, Virginia

Mayor Lyons opened the public hearing for any questions, comments or concerns. Mr. Cullip stated the proposed resolution was advertised in accordance with VA Code Section 15.2-1427 F in the Patriot newspaper on October 31, 2025 and November 7, 2025. There being no comments Mayor Lyons closed the public hearing.

Darrin Cullip, Utility

Mr. Cullip stated the broad band service workers had hit several lines where the town was off in marking underground lines. The town had a water break on Appleton Drive and replaced 400 feet of 4-inch line. The salt shed has been completed.

Mrs. Cox stated things were going well. The entrance sign is in the process of being replaced. Bids are being acquired for the fuel farm and roof replacement.

Mr. Seagle stated they are moving forward with several projects and closing out on some of the insurance claims.

Virginia's First-(VFRIFA)

Mrs. Hampton stated the next meeting is scheduled for December 10, 2025.

NRRA

Mayor Lyons stated the authority is in the process of doing their 2025 audit. Everything seems to be running well.

Mount Rodgers Cigarette Tax Board

Mr. Cullip stated council had in their packets a handout of the October 2025 Financial Report for their review. Everything is on track.

Motion to approve “Resolution to request the Commonwealth Transportation Board, through the Virginia Department of Transportation, to Prohibit through Large Truck Traffic on Giles Avenue (Town Road) within the Town of Dublin, Virginia, Pursuant to Virginia Code §46.2-809”

Mr. Cullip stated the county has approved to close their end of Giles Avenue. Doug Poe made a motion to adopt the resolution with an amendment on the second page last line to read, Adopted by the Town of Dublin, this 19th day of November, 2025. Wayne Seagle seconded.

Budget

Mr. Cullip stated General Fund Revenue is 22%, Expenditures are 33% and Revenue Enterprise Fund is 36%. Expenditures are 24%, 9% below what should be.

Christmas Parade 12/6/2025 at 11:00 am

Mayor Lyons stated the family of Doug Irvin Sr. had been recommended for Grand Marshal. Council agreed to ask the Irvin family. Five members of the council stated they would be riding in the parade. Line up will start at 10 am and the parade at 11 am.

Chamber Event 1/20/2025

Mayor Lyons stated the event will be held at the Volvo Customer Center with the doors opening at 5:15 pm; meal at 6 pm and the awards immediately after.

Employee Dinner 12/10/2025

Mayor Lyons stated Mission Barbeque will be catering the employee lunch. Debbie Hager will purchase desserts from Sam's Club. Lunch will be served at 12 pm and the Utility Department.
